Things I need to know:

This document lists all the funds in our *sigma* mutual fund range. Before making a decision you should read 'SIPP Client Investment Options and Fund Management Charges Guide' (SLSIP5a). This will give you an explanation of asset classes and general information on investments. It also details some of the risks you should be aware of. We strongly recommend that you speak to a financial adviser before making a decision on your fund choice. Information within this document was updated in September 2009.

- (1) Before buying a product, you need to be aware of the risks and commitment involved. Details are available in the 'SIPP Key Features Document' (SLSIP17).
- (2) The return on your investment in investment-linked funds is directly related to the performance of the assets in which they invest and the charges on the fund.
- (3) The price of units in investment-linked funds depends on the value of the underlying assets and can go down as well as up. You may not get back as much as you invest.
- (4) The sterling value of overseas assets in these funds may rise and fall as a result of exchange rate fluctuations.
- (5) The asset mix for each investment-linked fund is continuously reviewed and may be changed in line with developments in the relevant markets. A proportion of each fund may be held in cash and other money market instruments.
- (6) In order to maintain fairness between unitholders remaining in and unitholders leaving a fund, we may, in exceptional circumstances, delay transferring or switching all or part of your funds for up to one month or, in the case of units of a fund which invests directly or indirectly in buildings or land, for up to six months. If we delay the transfer or switch, we will use the unit prices that apply on the day on which the transfer or switch actually takes place.
- (7) If you decide to invest in a property fund, you should be aware that property can be difficult to sell, so you might not be able to sell your investment when you want to. In exceptional circumstances, it may take up to six months. The valuation of property is generally a matter of a valuer's opinion rather than fact.
- (8) You can switch your payments in and out of various funds to change the mix of investments.
- (9) Funds linked to the fund of external fund managers may be withdrawn at any time by their respective investment company – this is outside Standard Life's control. Standard Life is not responsible for the investment performance of these funds. The external fund manager may suspend dealings in their fund or delay withdrawals from it.

- (10) The charges and additional expenses are not guaranteed. They are regularly reviewed and may be changed in line with developments in the relevant markets.
- (11) As part of our investment strategy we may lend some assets of our funds to selected financial institutions, with the objective of enhancing the returns to the fund. In certain circumstances, for example if the institution encountered financial difficulties and was unable to return the asset, the fund could suffer a loss. As part of the management of a fund it is possible to use a number of controls, such as obtaining security from the borrower and monitoring their credit rating, in order to reduce the risk to the fund. External fund managers may also lend assets and are responsible for their own controls.
- (12) Funds may be able to use derivatives for the purposes of efficient portfolio management and in some cases meeting their investment objective. A derivative is a financial instrument, the value of which is derived from the underlying value or movement in other assets, financial commodities or instruments, such as equities, bonds, interest rates etc. There is a risk that a counterparty will wholly or partially fail to honour their contractual obligations under the arrangement. Where a counterparty fails the fund could suffer a loss. As part of the management of a fund it is possible to use a number of controls, such as holding collateral and monitoring credit ratings, in order to reduce the impact of this risk. Depending on how they are used, a derivative can involve little financial outlay but result in large gains or losses. Standard Life has control over the use of derivatives in its funds and external fund managers are responsible for their own controls.
- (13) Fund name and fund code – this provides the name of the fund and internal code used by Standard Life. Please enter both of these in full in the appropriate boxes when completing an application form. This will help us process your application more quickly and accurately.
- (14) Citi code – this is the external fund code.
- (15) Share type
- Income shares – any income received by the fund is paid to you as a regular income. This can be every month, every 3 months, every 6 months or every year depending on the chosen fund. The income will be paid directly into your bank or building society account on the distribution date(s).
 - Accumulation shares – any income generated is re-invested in the fund, which increases the share price.
- (16) Fund management charge – we make a fund management charge, which is set as an annual percentage of the value of your funds. We deduct this daily before we set the unit price. We calculate the unit price of your investment funds each working day. The charge for your pension plan varies if you invest in different funds. Please see the SIPP Key Features Document (SLSIP17) or Illustration for more information about the charges that apply to you.
- (17) Additional expenses – fund managers may charge an additional expense to cover costs such as trustees', registrars', auditors' and regulators' fees and safe custody charges. Where this charge applies, it is taken directly from the fund and is included in the unit price. For more information please see 'Mutual Funds – Fund Schedules' (MUFU43MF).
- (18) Initial charge – this is the one-off charge that applies every time you invest in a fund – it will be deducted from the amount you invest or, if it is a dual-priced unit trust, reflected in the price you pay.
- (19) Finex Crown Fund Rating – Finex (Financial Express) are an authority on performance measurement, providing data, advice and consultation to fund management professional and financial advisers. The Finex crown ratings are designed to highlight funds that have had superior, consistent performance in relation to risk, relative to their peer groups. Funds that have been assessed are awarded between 1 and 3 Crowns with 3 Crowns being the highest.

- (20) OBSR Fund Rating – these aim to provide professional intermediaries with a clear set of fund recommendations and alternatives to dovetail with their financial planning process. The ratings provision service focuses on UK authorised unit trusts, UK OEICs and “UK friendly” offshore funds. The ratings given are A, AA or AAA status with AAA being the highest. The ratings are subject to change and are not guaranteed.
- (21) Switch charge – a charge may apply if you decide to switch funds. Please see ‘SIPP Charges and Discounts’ (SLSIP20) for further information regarding charges.
- (22) Some income funds will allow re-investment of the income to buy further units in the fund. Speak to your financial adviser for further details.
- (23) Some Standard Life funds show an R at the end of the fund title, for example **Standard Life Investments Growth & Income R Acc (GI1)**. This means this is a retail fund and not restricted to institutional purchase.
- (24) New Star has temporarily suspended dealing in the **New Star International Property Fund (Citicode Y799 Fund Code V08)**.
